Hourly rate for one (1) to five (5) men 7:00 a.m. to 4:30 p.m. Job will be on an as-needed basis and may end at any time. Successful bidder must show Proof of Liability insurance not less than \$1,000,000.

Sealed bids will be accepted in the Administration Building, Scooba Campus, 1512 Kemper Street, P. O. Box 158, Scooba, MS 39358, or by electronic submission at [www.centralauctionhouse.com](http://www.centralauctionhouse.com) until 10:00 a.m., Thursday, May 28, 2026, at which time all properly submitted bids shall be opened.
